BACKGROUND INFORMATION:

The Mental Health Board is authorized by the Bronzan-McCorquodale Act, Section 5600 et. seq., California Welfare and Institutions Code, to advise the governing body and the Mental Health Director on any aspect of the local mental health program.

The Board consists of one member of the Board of Supervisors and fifteen members appointed by the Board of Supervisors that include consumers of mental health services, family members and professionals who have knowledge and experience of the Mental Health system.

The Health Care Agency has complied with procedures, as directed by the Board, in nominating appointments for Boards, Commissions, and Committees. Summarized below are the recommended appointments to the Mental Health Board:

~~Pamela Kahn is the Coordinator of Health and Wellness for the Orange County Department of Education. She is an active member of the Board of Directors, California School Health Centers Association and the Dental Health Advisory Board of Orange County. She holds professional membership in the Orange County School Nurses Organization, California School Nurses Organization, National Association of School Nurses, and American School Health Association. Ms. Kahn fills a Public Interest/Mental Health Professional slot for the Mental Health Board.~~

Jenny Monge is an Outreach Presenter for the National Alliance on Mental Illness in Orange County. She is responsible for providing outreach and education information to high school students throughout Orange County. Ms. Monge fills a Consumer Direct slot for the Mental Health Board.

Richard McConaughy has over 30 years in the education field as a Substitute Teacher, Mental Health Counselor, and Associate Dean of Students Services/Counseling. He received his Ph.D. from the University of Illinois, Chicago in Higher Education Administration in 1974. Richard McConaughy is a past member of the Kitsap County Mental Health Board and Kitsap County Planning Commission. Mr. McConaughy fills a Public Interest/Direct Consumer slot for the Mental Health Board.
