RECOMMENDED ACTION(S)

Call a special election to fill the vacancy in the Office of First District Supervisor to be held on February 6, 2007.

SUMMARY:

The Orange County Charter requires that the Board of Supervisors call a special election to fill the vacancy in the office of First District Supervisor. February 6, 2007 in the last Tuesday on which the election may be held.

BACKGROUND INFORMATION:

The resignation of Supervisor Correa, effective December 4, 2006, has resulted in a vacancy in the office of First District Supervisor. Pursuant to the County Charter approved by the voters on March 5, 2002 (Measure V) and Orange County Codified Ordinance Sec. 1-2-9, the Board of Supervisors is required to call a special election within three business days of the vacancy, to be held on a Tuesday not less than 56 days nor more than 70 days after the vacancy occurs. The charter provides that the individual who receives a plurality at this election will fill the unexpired term. There is no provision for a runoff.

FINANCIAL IMPACT:

An adjustment to the agency budget will be submitted through the Second Quarter Budget Adjustment process to cover the additional costs.
