

Since becoming the Recruitment and Selection Supervisor in December 2006, Jany is responsible for overseeing all aspects of the recruitment and selection process for the City, including Police and Fire, while performing a variety of personnel administrative functions including job analysis, classification and compensation studies, test construction and other selection techniques, employee development and training.
