SUMMARY:

The Children and Families Commission of Orange County's 2011 calendar includes the dates for the monthly Commission meetings, and the quarterly meeting dates of the Commission's Pediatric Health Services Committee.

Children and Families Commission Monthly Meetings

The Commission meets on the first Wednesday of the month at the Orange County Hall of Administration located at 10 Civic Center Plaza in Santa Ana in the first floor hearing room. Exceptions to the regular meetings are the annual planning meeting scheduled for June 1, 2011 at an off-site location that will be determined at a later date, and the Commission does not meet in August.

Pediatric Health Services Committee

The Pediatric Health Services (PHS) Committee was formed by the Commission to provide comprehensive planning, fiscal and administrative oversight, and respond to community needs on specialized health programs. In 2011 the PHS Committee is scheduled to meet on January 5 and March 2. The PHS meetings immediately follow the regular Commission meetings at the Orange County Hall of Administration.
